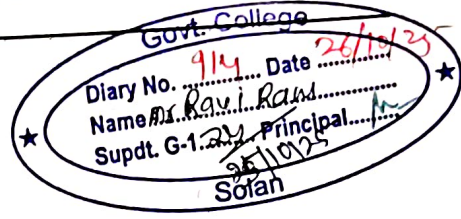
Madam,


Shared Use of College Ground for Forest Department Practice and Community Fitness under the Fit India Movement

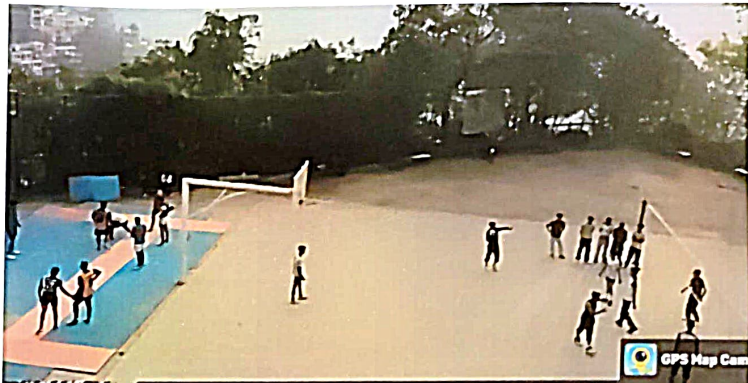
